Green shipping Technical Group (TG)

<u>Description</u>: The Green shipping Technical Group (TG) will further develop project ideas, by building upon the achievements so far and based on the priorities defined in the latest TG meetings. This includes the role of the TG on fostering re-structuring a Mediterranean supply chain for the shipbuilding industry, the steps ahead toward the WestMED Alliance of Energy Communities in Ports and the clusters of Maritime Transport operators along the main Mediterranean routes, as a way to tackle the main sustainability challenge through the concept of 'Connectivity'.

<u>Description</u>: Maritime clusters are the backbone of support for uptake of knowledge and innovation for local blue economy businesses and other relevant players in innovation ecosystems. The WestMED Cluster Alliance has been very successful in supporting relevant projects and expanding the network of maritime clusters from northern to southern countries, with new cluster organisation under activation across North African Countries. The discussion will reflect on the achievements so far to identify effective next steps in the implementation of the Roadmap for Clusters Cooperation, as defined in 2022 - including as a way to engage with relevant regional bodies (African Union, etc). The World Ocean Council (WOC) will participate in the session presenting the project proposal GREEN MARINE MED.


